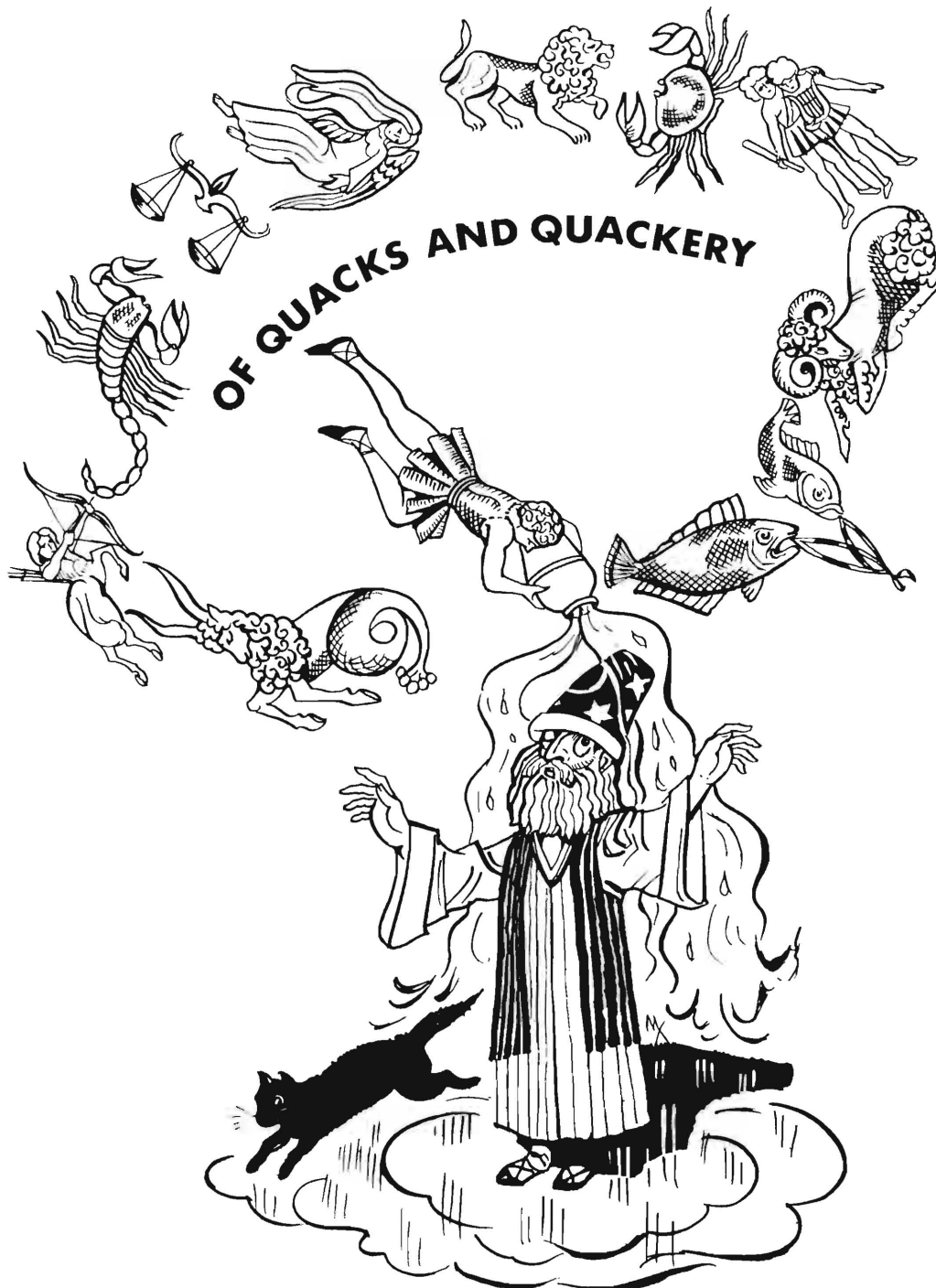

THE SECOND DEATH

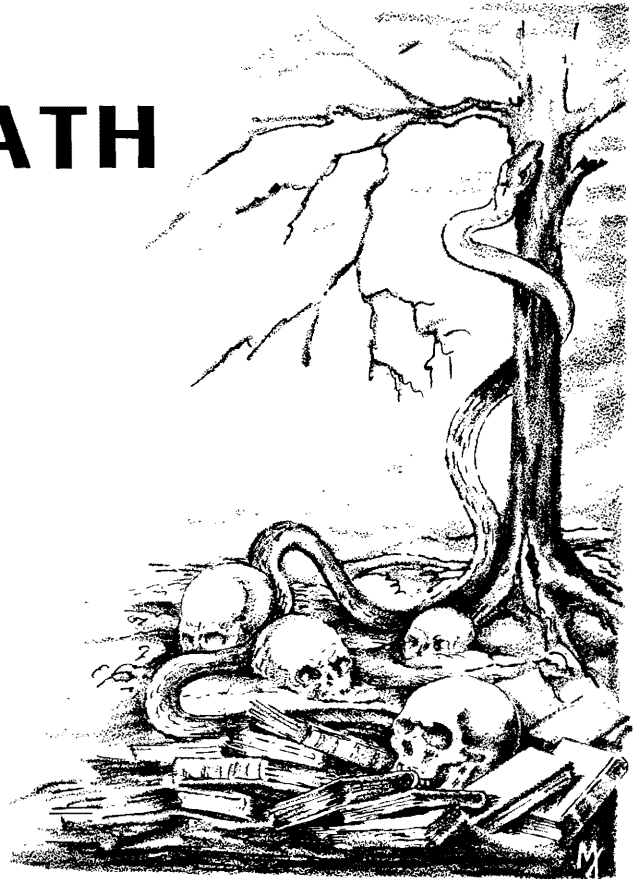
Man is mortal. Race is longer-lived, verging for some of us on the brink of immortality. Man sees his renewed and future life in the clear eyes and glowing skin of his children. As his descendants become more remote, they dissolve into the collective posterity known as race. Even the childless man, owing to the procreational activities of close or distant relations, entertains the high hope of avoiding the Second Death—the racial death—which adds the extinction of his people to the extinction of himself.

The Second Death is now glimmering in the cold mathematical doodling of the demographers, who, having replaced the portentous prophets and millenarians of the past, are now monopolizing the art of doomsaying.

In 1972, warns Colonel Robert de Marcellus in a paper written for the Army War College, the U.S. fertility rate went below the “replacement level” of a minimum of 2.1 children per family. After sinking from 3.5 in the 1950s to 1.9 in 1974, it fell to 1.7 in 1977. Nonetheless, the U.S. population will continue to increase as a result of immigration and the lowering of the death rate. The total number of Americans will not decline until 2020. By that time, however, the country will have a radically different racial mix, as minorities, particularly the Unassimilable Minorities, outnumber the Northern European segment of our population. According to de Marcellus, Wasps, with a fertility rate of only 1.5, will be slightly more than half their present number in two generations and will be less than 10% of the population in two more. The Jews, with a fertility rate of slightly more than 1, will be traveling much faster and much more furiously along the road to extinction. And speaking of Wasps and Jews, the 900 women who have graduated from a high-ranking Ivy League college in the last five years have given birth to exactly three children. Only 120 of these women, who are overwhelmingly Wasp or Jewish, have even married.

In many European nations the fertility rate has also dropped below the 2.1 replacement figure. In West Germany it is now 1.5 and it is probably lower in East Germany. In Sweden it is 1.57, Britain 1.8, Hungary 1.9, France 1.9. Only Ireland, Belgium and the Eastern European nations are above ZPO (zero population growth).

For an idea of how fertility rates work, take the case of five couples who each have one child, who in turn has one child, and so on—a fertility rate of 1.5. In five generations the five original families would reduce to .625 of a person. On the other hand, one couple with four children, each of whom in turn has four children—a fertility rate of 4—would produce 32 persons in five generations. To give a specific



case, Sweden, the nation with the world's lowest fertility rate (1.57), will lose about 25% of its population every generation.

The falling fertility rate is blamed by demographers in part on worsening economic conditions, in part on women who “postpone” having children until it is too late. Responsible couples are hard put to afford babies any more, certainly not a lot of babies. More and more families need the work of both spouses just to make ends meet. Equally depressant on birthrates are new and more reliable contraceptive devices, quick and practically painless sterilization procedures and the legalization of abortion. There were 892,000 abortions in the U.S. in 1974—more than four times the number in 1970. De Marcellus estimates that without these abortions the 1974 U.S. fertility rate would have been 2.7 instead of 1.9. Today, American women are averaging one million abortions a year, a figure which may soon double. Abortions seem to do as much damage to birthrates as to fetuses. On the other hand, when legal abortion was forbidden in Rumania in 1965, the fertility rate rose from 2 to 3.7. Conversely, after abortion was legalized in Japan, the fertility rate fell from 4.5 to 2 in one decade. Meanwhile, another technological refinement that may have a more shattering effect on birthrates than abortion is looming on the horizon—the predetermination of the baby's sex. Such a “breakthrough” may materialize any day, which would mean that parents would no longer have to “try again” for the wanted boy or girl.

To demonstrate the qualitative change now taking place in the American population, in five

QUIET THUNDER

The following brief for Britain's National Front could serve, with only a few word changes here and there, as a manifesto for the American Majority party, once it is formed and once, as will inevitably be the case, it is confronted by the same street gangs, political hooligans and media goons who are determined to nip in the bud any rebirth of Western race consciousness.

Never in the history of the British people has a political party been so attacked, travestied and slandered as the National Front! No political party has ever been so totally and deliberately denied every public means of reply by those monopolising the summits of power, authority and mass media.

Doesn't this strike you as very strange? Doesn't it make you wonder what is going on behind the scenes in Britain?

What is it about the National Front that makes it imperative for shadowed people of high influence to deny us the use of public halls for our meetings? (Halls that we ourselves, as ratepayers, support financially for the general good.) To refuse us the right to reply to their vicious and childish lies in the press... on television... on radio? To prevent us demonstrating or marching in an orderly manner like any other party?

The answer, of course, is that all three established parties will stop at nothing now to destroy us. Despite all the odds, our numbers are inexplicably growing and the mandarins have suddenly stopped smiling and ignoring us. The jarring truth is that they know we cannot be bought off with cant, bribery or under-the-counter *quid pro quo* deals, so their answer is to open up a war of hate against us, jettisoning all pretence of democratic principles and decency.

To win your approval for this, they reopen the war graves of our enemies and call us Nazis and Fascists, calculating by this ruse to rouse the hatred, hysteria and blood-lust of those days in order to incite the scum of the extreme Left Wing to employ physical violence against us. It is significant and ominous that that deception has been seized upon by every party, together with their miserable organs that drum up public opinion or hysteria, as the case might be.

If you are a patriot and see sense in our crusade, you can expect the same scurrilous treatment, even if you really fought real-life Nazis and Fascists, as we did. But it doesn't indicate a very great respect for public intelligence or courage, does it? Our opponents say, in effect: 'Go over to the National Front and we will bully you as we are bullying them. And it's very cold out there, friend!'

But think about it as an Englishman or woman, traditionally never a person too susceptible to bullying!

Over the past few years the stench of corruption and scandal has risen in quite visible fumes over every established party. Now we see them for the rotting, putrescent hulks of the past that they really are. They call themselves Conservatives, Labour or Liberals, but the vari-coloured labels are all marked to the same terminus: a public dead loss! The greed, calculation and

hypocrisy are unchanging in every face, whether in office, or queuing up to get back in. These people care nothing for Britain, its interests, or even your opinion of them: once they've tricked you of your vote, that is!

For thirty years these men have showered honours on themselves, banqueted on beluga, grovelled and ingratiated their way into every nook and cranny of privilege and private profit. In this short time, our "Parliamentary representatives" have frittered away our national heritage, our wealth, our possessions, our honour, our pride, and our very identity.

They have left us—just thirty years ago a great World Power—defenceless against attack.

They have taken us to the highest level of taxation in the world, and in our history.

They have proliferated laws that have created an army of artificial criminals, all of whom would once have been honest citizens.

They have stolen away the right of free speech, of free assembly, and free expression.

They have violated the sanctity of the home, and individual privacy. Now an army of threatening officials are empowered to break into any house, contradicting the age-old axiom that an Englishman's home is his castle...

They have expanded bureaucracy to insane levels requiring multitudes of parasites in a State grown blind to freedom and individual happiness.

They have denied the right of small people with limited capital to begin, or continue, their own businesses in profitable independence.

They have transformed a once benevolent State into a monster of rapacity that punitively punishes every motorist, every shopkeeper, every businessman and every householder with fines, taxes, levies and rates totally in excess of services rendered. There is not a criminal in the United Kingdom today who swindles and robs with the insolence of the State itself, manipulated by the apostolic succession of our opponents in and out of office!

No heartless dictator could have done more to damage us than has been done by democratic processes through your votes to these parties.

But now, worst of all, these people have declared an inflexible policy of mongrelising our race, camouflaging the extinction of the British under the euphemism of "multiracialism." In doing so, they have created racial hatred for the first time in our history by introducing and encouraging the growth of alien communities that do not belong here. Furthermore, all major parties have deliberately falsified the numbers of resident immigrants, well knowing if their population

A gallery of ancient and modern hoaxers

OF QUACKS AND QUACKERY

For many years, each issue of the *Scientific American* has been enlivened by a series of mathematical and logical puzzles presented, and often devised, by Dr. Martin Gardner. In June 1974, however, the ingenious mathematician tried his hand at broad humor, with the unexpected result that the June issue soon became sociologically the most informative that the periodical has ever published.

Starting on p. 116, Dr. Gardner, keeping a straight face in the manner of Baron Munchausen, reviewed the wonders of pyramids and led his amused reader to a tall tale about a certain Dr. Matrix, whom he had interviewed in a great laboratory and factory, a copy of the famous pyramid of Cheops, on the shore of Pyramid Lake, north of Reno, Nevada. That great numerologist, he said, had discovered that the roughly pyramidal monadnock from which the lake takes its name attracted and concentrated "psi-org" power from outer space, thus turning blue the waters of the lake. A sequence of ever more marvelous revelations followed, until Dr. Gardner ended his tale on p. 120 in a spirit of broad farce. Readers of the magazine, according to their temperaments, chortled or guffawed, and there the matter should have ended.

The *Scientific American*, though it frequently strays from hard science into pure sociological bunkum, is not one of the favorite journals of the feeble-minded, so what happened next must remain a mystery, unless we entertain the fearful hypothesis that it may be read by persons with enough scientific knowledge to understand some of the articles, but not enough common sense to recognize absurdity. However that may be, Dr. Gardner's joke got into the hands of nitwits, some of whom rushed to Pyramid Lake to consult Dr. Matrix, while others offered Dr. Gardner honoraria for lectures on the miracles wrought by "psi-org." It also came into the hands of one of the largest publishers in New York City, who at once wrote Dr. Gardner, flourishing a \$15,000 check as an advance on royalties from a book on "pyramid power." Astounded, Dr. Gardner explained that it was all a joke. "What of that?" the publisher replied in substance, "you write the book under a pseudonym and we take the suckers for lots of bucks, no?" Dr. Gardner refused the proffered shekels. Astounded, the publisher, doubtless concluding that Dr. Gardner must be lame in the head, found brighter penmen and soon the stands in drug stores and hotels were spotted with bound bundles of drivel about "pyramid power."

This is a datum that must not be disregarded by anyone who is interested in the possible survival of our race. As Philip Morrison remarked in his review

of Gardner's new book *The Incredible Dr. Matrix*, "Such is the current state of the obsessive will to believe, and such is the cynicism of many who exploit it." The first law of applied sociology, as formulated more than a century ago by one of the foremost experts in the field, P. T. Barnum, states that a sucker is born every minute. The birthrate, which Barnum may have underestimated, has naturally increased since his time, enormously so according to incontrovertible data that have become available during the past decade.

On the subject of pyramids, I should remark that I.B.M. manufactures office machinery that sells at prices that range from under \$500 to more than \$55,000. Such gewgaws are not likely to be found in the hovels of the "underprivileged." The corporation has a competitor, which manufactures and sells supplies for I.B.M. machines, such as type fonts, carbon ribbons, and correcting tapes, and naturally sends its catalogs to the owners of such machines. It also offers its presumably literate customers an opportunity to buy a wonderful locket to hang about their necks. The locket has a picture of a pyramid on it and thus accumulates "pyramid power" from "bio-cosmic rays," so that it "increases ESP, romance, relaxation, attract [sic] money, gives one a feeling of being truly alive and perform [sic] many experiments." This magic device, which also has a "secret compartment" in which you can put a four-leaf clover or other charm, presumably to pep up the "bio-cosmic rays," is certainly a bargain at \$9.95, but if you have an office staff that you want to equip with "ESP" and fill with *joie de vivre*, you may obtain the miracle-making amulets for only \$30 a dozen. Now I remind you of the class of prospective customers to whom these catalogues are sent, and I ask whether you do not feel cold shivers running up and down your spine.

Superstition will always be epidemic among ignorant persons, such as politicians and chimney sweeps, and among races of low mentality. What is noteworthy is the dire increase in credulity among members of the American Majority who think themselves educated because they learned to read simple English while their minds were being pickled in the public schools and the institutions that still call themselves colleges. They form the principal market for the tons of printed piffle that is constantly manufactured by publishers who are, almost without exception, members of the predatory minority.

Comparatively innocuous are the wonder books concocted by Erich von Daeniken and his less cautious imitators, such as Andrew Tomas, who have learned the simple art of creating mysteries for the credulous. Nothing is more commonplace than

DISSIDENTS' CORNER

Instaurationists, thank God, are not of one impermeable mind. We often receive letters, some of them long ones, which intelligently question our most cherished themes. Here are parts of two such communications.

Nordic Dysfunction

The article "The Racial Basis of Tyranny" is very good, but it does not follow through on its own logic. In plain English it says that the Nordic cannot compete successfully with any other race, not even the Negro. The only way the Nordic, as we now know him, can survive is in absolute isolation where he (or she) never sees an Italian or a Negro, let alone a Russian or a Jew. The political institutions of the Nordic are utterly childish and asinine. They do not even work for him, yet he tries to force them on every other race on the globe. He lives, works, fights and finally dies to palm off his institutions on the ungrateful darkies of every continent.

It may well be true that the Nordic is the most intelligent and creative race. These, however, are not of themselves the best traits for survival. The world is full of brilliant professors, many of them Nordics, who cannot function at all in the everyday world.

The Nordic's abstraction-oriented mind has lost him his instincts and his rationality. A successful superrace must have *both*. Since he cannot cope with reality, he attaches himself to some "cause," some institutional abstraction. It may be Jesus, free enterprise, socialism or any other crackpot philosophy that strikes his fancy when his adolescent mind is open for imprinting. It hardly matters that most of these ideologies have negative survival value. The more self-destructive the philosophy is, the more it appeals to the young Nordic. The American Civil War and World Wars I and II were not mere political wars. They were religious crusades where Nordic manhood could perform its finest duty—slaughtering other Nordics by the millions.

The Nordic cannot lead a normal life. Either he must be an ascetic or a hedonist. Entering a Protestant Christian household is like a visit to the madhouse. The atmosphere is poisoned by the internalized hatred.

Instauration's great fault is that it is directed to the minority of minorities—Nordics with a capacity for mental health. I would say that *Instauration* has already reached at least 10% of these and maybe as much as 80%. Obviously the possibilities for growth are not too good, since Nordics, like Jews, are oversexed, but underfertile.

Let's get serious about the project of conserving Nordics, who after all are a very valuable resource. If we can save the whooping crane, we can save the Nordic. It is almost certain that Nordics will not be conserved by Nordics, but by other whites who appreciate the value of things better and who are more mentally and emotionally stable. It may well take a committee of brachycephalic white scientists to create the Nordic superrace, while the young Nordics who have not been interned in state stud farms are pursuing their usual activities; fornicating with Negroes, worshipping Jesus,

promoting socialism, selling life insurance, etc.

To conserve Nordics, the environment and anything else worthwhile, we must first get rid of democracy, Christianity, equality, rule-by-law and other nonsensical drivel. The state would have to be powerful, but not bogged down in trivia like the U.S. and U.S.S.R. Private enterprise should run most of the economy, but under strict federal rules and regulations. The purpose of the state would be to improve the white race, not to give every slob a Chevrolet and a color TV. I will not attempt to formulate a legalistic perpetual motion machine that will keep the state doing what it is supposed to be doing. These things are gimmicks and never work for very long anyway. The U.S. Constitution was a clever gimmick, but its day is long past. No political system is going to make people any better than they are. Marx is not so wrong as he is irrelevant. The same for Milton Friedman.

The new state should be built on science and esthetics, not economics. Economics could probably be tamed, if only we could eliminate the economists. There are adequate solutions for these technical problems, provided we had the chance to implement them.

The educated professional classes in the English-speaking world are the prime movers of white extinction. All Jews and Communists who have helped them have been opportunists. The Jews are now having second thoughts, to put it mildly. So are the Russians, now that the U.S. government is thinking about selling China the large-scale integrated circuits that could let it pinpoint nuclear warheads on the Kremlin.

Are We More Sovietized than Zionized?

The major political operation of the moment is the systematic, carefully planned destruction of every important remaining base of Western civilization that lies outside the immediate military control of the Soviet government. Several parallel lines of action are pursued. The most important in the long range, because for all practical purposes it is irreversible, is the rapid mongrelization of these areas. Southern Africa is where the Russian strategy must be apparent even to educated ladies trained in the proper liberal verbiages. There the operation varies from small private raids bent on murder and rape, through Soviet armed and supported Vietnam-type incursions from sanctuaries, to the huge crushing weight of international arms and trade boycotts—of whites only, of course. Every part of this monstrous activity is knowingly promoted by the manifestly joint efforts of the U.S. and the Soviet governments, the former supplying the political muscle and the proper moral tone, the latter furnishing the arms and the worldwide support of leftwing and liberal parties.

GERMAN REPARATIONS TO JEWS

Most of us are at least vaguely conscious of the immense part the U.S. has played in the creation of Israel and of the immense public and private financial aid that has flowed from America to the Zionist state over the last thirty years. But only a handful of Americans are familiar with the aid-to-Israel program of West Germany, which on a per capita basis greatly exceeds the amount of private and public money sent to Israel from America.

Under U.S. prodding, the Federal Republic of Germany in 1953 signed a treaty with Israel in which it promised to pay 3 billion marks in commodities and services over a period of twelve years. One-third of this money was to go to British (not American) petroleum companies for oil deliveries to Israel. One-third was to pay for orders placed by Israel with West German firms. Some 450 billion marks was to be allocated to twenty-three Jewish organizations on behalf of indigent Jews who had been victims of Hitler.

In fulfilling its treaty obligations West Germany built an entire merchant marine for Israel (including 59 ships and a drydock), repaired and rebuilt Israel's telephone and telegraph network, constructed a copper plant, steel plant and five power plants in Israel, laid 280 kilometers of irrigation pipeline, laid new railroad tracks over most of the depleted railway system, for which it delivered 400 boxcars, passenger coaches and diesel locomotives. One Kibbutz received \$200,000. Needless to say, this economic assistance was of great military importance. Some believe that without it Israel's many wars with the Arabs might have had a different outcome.

The above payments do not include the much, much larger amounts paid directly by Bonn and by provincial German governments to individuals who claimed to have been victims of Nazi persecution. These personal reparations were initiated by provincial governments upon the demand of American officials as early as 1949. Up to 1974 these payments totalled 52 billion marks (the mark has increased in value over the years, but at the present rate of exchange this would amount to almost \$28.5 billion.



Although many more non-Jews than Jews died, were injured or suffered financial losses during World War II, Jews have received ninety percent of all German reparations. About 4,300,000 requests for reparations have been received from survivors and their families (another indication that the "extermination" of European Jewry is just another myth). All but 16,954 of these claims have been settled. The cut-off date for applications for the *Wiedergutmachung* was supposed to be 1969. Yet last year's payments amounted to nearly \$900 million. At present the Bonn government is figuring that the program will last until 2000 and that the total cost will then reach the figure of 85 billion marks or \$43 billion. This certainly represents the highest reparations payments in the history of warfare.

If Jewish statistics are to be believed—in other words if there were practically no Jewish survivors in Europe—then only a few individuals would have divided up the \$28.5 billion paid to Jews as reparations. But thousands of Jewish lawyers and doctors have been given lifetime pensions. Jewish inmates of concentration camps have been given five marks a day for every day of their confinement. Non-prisoners were given the same amount for being locked in ghettos or for every day they were forced to wear the "yellow star of David." Students were given large sums to compensate for their lost education. Widows of Jews who died solely because of typhus or other disease averaged 200 marks a month. The maximum monthly pension is 1,800 marks. Some lump sum payment settlements have been as high as 500,000 marks.

The West German government has refused all requests for a complete accounting of its grants to Israel and payments to Israelis. Consequently, what has been disclosed above may be only the tip of the iceberg. The monetary value of the uranium hijackings, which were actively assisted by the West German government, remains another dark and inviolable secret.

The huge financial sacrifice on the part of the West German population has been explained on

CHOICELESS



POLITICS

When it comes to life and death issues, the issue of war or peace, the issue of Majority or minority rule, American democracy differs little from totalitarianism. The public never had a chance to vote on entering World Wars I and II, and the Korean and Vietnam wars. Before these conflicts both Republican and Democratic presidential candidates ran on peace platforms. Once in office, however, the presidents led the country directly or indirectly into war. No candidate in the preceding presidential campaigns ever asked the question, "Why not let the Germans conquer Europe, the North Koreans forcibly unite Korea, the North Vietnamese take over the South Vietnamese?" It would have been much better for the world, for peace, for prosperity, if we had allowed the stronger nations or national factions to prevail at the very start. Many of tens of millions who died in these wars would still be alive or at least their descendants would still be alive. What was the good of delaying the victory of North Vietnam for a decade or so? Why keep propping up a South Korea that needs U.S. troops to save it from North Korea? The defeat of Germany produced today's monstrous Russian military machine which is quite able, if not quite ready, to swallow Western Europe in one fearful gulp.

In the more important realm of race, Americans have had even less chance to register their feelings. Both parties are equalitarian from top to toe, both fawn on minorities, both look with chicken-livered equanimity on the mongrelization of our cities, our culture and our government.

In recent decades, in spite of their bull-horn pretensions to the contrary, the Republican party has always presented a subliminal image of standing up for white interests. Its commitment to the minorities seemed more apparent than real, if only in reaction to the Democratic party, which under the New Deal became the party of miscegenation. The growth of the Republican party in the South was due in part to the perception that it was the party of the Majority and a political antidote to the voting rights laws opening up the southern wing of the Democratic party to Negroes. The antiwhite stance of the Democrats was only threatened once in recent times—by the Wallace movement. This embarrassing interlude was ended by Arthur Bremer's pistol.

Today, as opposition to all forms of integration continues to mount, the Republican party should logically be expected to polish its white image and seek to counter minority-bloc voting, the political power base of the Democratic party, with Majority bloc-voting. But in the good old tradition of choiceless American democracy, this is not what is happen-

ing. The Republican wire-pullers are now busy trying to steal the Negro from the Democrats by promising him more welfare, more integration, more affirmative action. Even truer to form, the Republicans are attempting to lure Jews away from the Democrats by offers of more money and more arms for Israel and less aid and less even-handedness toward the Arabs.

Bill Brock, the Chairman of the Republican National Committee, is the man most responsible for his party's recent cozying up to blacks and Jews. He admits that everywhere he travels in the U.S. these days he deliberately seeks out Jewish support.

Howard Baker, a potential Republican presidential candidate in 1980, was wined and dined in New York last January by Laurence Tisch, a multimillionaire New York Democrat who gives almost \$1 million a year to Israel. To demonstrate his gratitude Baker gave a rousing pro-Israel address to the World Jewish Congress. Senator Robert Dole, another Republican presidential hopeful, in the midst of an obligatory pilgrimage to Israel praised Begin as a sort of Semitic George Washington and supported Israel's no-peace policy. On his return to the States Dole had some honeyed words for the second most powerful bloc of minority racists, "Our job now is to demonstrate our concern for blacks and others who doubt our sincerity." A few weeks later California Republican party Chairman Mike Montgomery, a Reaganite, invited the Jewish racist, Senator Javits, to do some fundraising for the party in the Far West.

In addition to wooing the Unassimilable Minorities the Republicans also plan to capitalize on the victory of Proposition 13 in California. At bottom this is a racial revolt. But you can depend on Republican leaders and the men behind Proposition 13 to keep the truth from the Majority rank and file. Just as surely as Joe McCarthy and George Wallace failed because they both avoided the racial issue, so too will the Proposition 13ers as they try to expand their local political triumph into a nationwide movement.

Howard Jarvis is a Sinclair Lewis character, a cantankerous old Babbitt whose charisma is confined to a rasping, earthy salesmanship which would do credit to Willy Loman. His is a dollar-and-cents politics designed to appeal to the ever thinner wallets of the financially strapped middle class. But tax revolts have a materialistic ring to those Majority romantics who prefer ideals to savings accounts and who feel that as long as Americans place their destiny in the hands of third-rate Joe Blows like McCarthy, Wallace and Jarvis, just so long will second-raters like Ford and Carter hold forth in Washington. You don't kick baboons out of office with monkeys.

The Cultural Catacombs

No Entry

In the recent article on "Racism in English Literature" (*Instauration*, Aug. 1977), writes a subscriber, unmentioned was this pithy statement by Mr Deasy in Joyce's *Ulysses*:

—Mark my words, Mr Dedalus, he said. England is in the hands of the Jews. In all the highest places: her finance, her press. And they are the signs of a nation's decay. Wherever they gather they eat up the nation's vital strength. I have seen it coming these years. As sure as we are standing here the Jew merchants are already at their work of destruction. Old England is dying.

Rather hits the mark, doesn't it? And further on:

I just wanted to say, [Deasy] said. Ireland, they say, has the honour of being the only country which never persecuted the Jews. Do you know that? No. And do you know why?

He frowned sternly on the bright air. —Why, sir? Stephen asked, beginning to smile.

—Because she never let them in, Mr. Deasy said solemnly.

A coughball of laughter leaped from his throat dragging after it a rattling chain of phlegm. He turned back quickly, coughing, laughing, his lifted arms waving to the air.

—She never let them in, he cried again through his laughter as he stamped on gaitered feet over the gravel of the path. That's why.

Russian Futurology

The London *Daily Telegraph* is the only mass circulation daily newspaper in the English language that can properly be called pro-white. That is, it frequently puts the interest of Britons above those of the "coloureds" both at home and abroad. What's more, the newspaper is singularly free of minority racism, which is the great debaser and corrupter of the Western media.

Last March the *Daily Telegraph* ran a story about Valery Emelyanov, a prominent Russian political analyst who had submitted a paper to the Presidium of the Supreme Soviet accusing Soviet Jews of forming a fifth column "as dangerous to the Motherland as the Volga Germans and the Tartars were in World War II." Emelyanov allegedly added, "In case of a new war we shall not even have time to

organize against the internal danger that we had in 1941." The Russian then lamented that the number of Soviet Jews who did not want to emigrate was greater than those who had already left. "It is no secret that they must remain in order to undermine us from the inside." The bottom line was a proposal to establish a worldwide anti-Zionist front similar to the Moscow directed anti-fascist fronts of the 1930s and 1940s.

About the only U.S. daily that can be compared even remotely to the London *Daily Telegraph* is the *Christian Science Monitor* which recently published an interview by Andrei Amalrik, the Russian expatriate who wrote *Will the Soviet Union Survive Until 1984?* Amalrik, now a teacher at Harvard, has begun to backtrack on his Orwellian date. He says he was too young when he wrote the book. "Young people tend to think that things are going to happen more rapidly than they, in fact, do." He also admitted that he had "underestimated the flexibility of the Soviet leadership and exaggerated his claim of a coming Soviet-Chinese conflict."

Amalrik correctly sees great instability in the mere existence of the Soviet Union's 50 separate nationalities (22 with a population of over 1,000,000). He incorrectly discounts the present trend of "Russification" as a sign of weakness, when it could be more logically interpreted as a sign of strength. Amalrik totally discounts Pan-Slavism, while admitting that Slavs make up almost 70% of the Soviet Union's population. If properly refurbished and presented as a substitute for Marxism, Pan-Slavism might keep Russia going for centuries.

The mere fact that the Soviet Union is bound to undergo some radical changes does not mean it will collapse in 1984 or 2084. Because Marxism is moribund it does not follow that Russia, with the greatest peacetime military force in world history, is also moribund. There are many people who would bet Amalrik that the United States, not the Soviet Union, will come in first in any superpower collapsing derby. Ideologies change. Nations remain. We have only to cite the radical turnabouts of England in the 17th century, France in the 18th, Germany in the 20th. Even universal religions are short-lived compared to the Methuselah life span of races.

The white nations which are going to

survive and prosper in the 21st century are those which reverse the pandemic lowering of the white birthrate. Dictatorships will have an easier time solving this monumental problem than democracies, especially multiracial democracies.

Esthetic Disharmony

John Gardner, one of the few Majority novelists left on the literary scene, has just come out with a book called *On Moral Fiction* (Basic Books, \$8.95). His principal line of thought is that art must have "a clear positive moral effect, presenting valid models for imitation, eternal verities worth keeping in mind and a benevolent vision of the possible which can inspire and incite human beings toward virtue, toward life affirmation as opposed to destruction or indifference."

The *Chicago Sun Times*, for reasons best known to its book editor, assigned the review of Gardner's book to a New York free-lance writer named Sheldon Frank, who called it, "so pretentious, so banal, so repetitive, so intellectually primitive, so self-righteous, so self-serving and, perhaps odd for a volume ostensibly devoted to humane values, so mean-spirited that even calling it a work of nonsense is being generous."

This is the kind of shrewish, sideshow barker reaction that can be expected in a multiracial society where ethos clash by day and night. When there is no instinctive understanding between author and critic, where reader and writer are genetically and therefore esthetically out of tune, literary criticism easily degenerates into pure drivel and pure hate.

Criminal Politics

The Southern Christian Leadership Conference, Martin Luther King's old racket, has just honored Henry T. Cianfrano with the title of "Man of Distinction." Cianfrano, a Pennsylvania politician, is presently serving a five-year prison sentence for corruption.

Democratic congressional candidate Robert Klepak of Illinois recently withdrew from the race against Republican Philip Crane, when he was arrested by the FBI for possession of stolen savings bonds.

Congressman Daniel J. Flood of Pennsylvania was bribed five times by a Brooklyn rabbi, according to the Department of Justice. The bribes were mainly for Flood's support of legislation for multimillion dollar federal programs.

Joshua Eilberg, who is the man to see in Congress about immigration, as been accused of corruption involving the building of a Philadelphia hospital.

Michigan's leading black congressman, Charles Diggs, is now under investigation by the Department of Justice for sundry financial crimes.

Edward Brooke of Massachusetts, the only black senator, may have committed perjury when revealing his assets in a divorce case.

Senator Herman Talmadge of Georgia is now under investigation for pocketing unreported campaign contributions.

We were happy to list Republican Flood and Senator Talmadge among these wrongdoers. They are the only two Majority members. Their inclusion does not affect the tremendous overrepresentation of minority politicians in crime. So many black politicians are involved that the law enforcement authorities are being accused of racism. Needless to say, many of the culprits, among them Flood and Eilberg, have been renominated by their respective parties for reelection.

In the 1976 election, of twenty-one incumbent congressmen linked directly or indirectly to lawbreaking, nineteen were reelected.

The Robots Are Coming

The first production run of household robots is scheduled to take place within the next two years by a

small company called Quasar Industries—or at least that's what the press release says. The robots will be 5'4" high, weigh 240 lbs. and have a walking speed of up to 20 miles per hour. Cost will be approximately \$4,000. The robot will be programmed to serve dinner, vacuum, babysit, answer the front door and serve drinks. It will have a 250-word vocabulary.

What does this all mean? It means that in an increasingly technological society certain types of people will be even more unnecessary than before. The welfare rolls will swell. But will the age of servants and domestic help return? Not necessarily. Some non-robots will probably start a robot union, press for robot ERA and introduce a robot relations law to protect our inorganic friends from organic supremacists.

High Culture

Jesus Christ Superstar returned to Chicago—with a few snappy revisions. There was a prominent display of male backsides, and in "King Herod's Song," Herod, depicted as a loathsome homosexual, exhorts the kneeling Jesus to perform a miracle. To make his point he pushes his pelvis into Jesus's face, as he sings "Change My Water Into Wine."

Meharry Medical College in Nashville, Tennessee, which turns out nearly half of the country's black physicians and dentists, defaulted on a \$29 million loan. The money was ninety percent guaranteed by HEW (which rhymes with you). Now HEW—and you—and I—must take over the monthly payments of \$170,000.

Veronica Brunson was first arrested for prostitution in New York in 1977 when she was 11 years old. Within a year she had been arrested 12 more times for the same offense. At the age of 12 she fell 19 floors to her death from a midtown New York hotel. Police believe she was pushed out the window by her Negro pimp.

Miami-Dade Community College, Duke, Georgetown, U. of Illinois, Hampton Institute and Wooster College spent from \$9 to \$10 million in the 1974-75 school year on additional administrative costs in complying with twelve federal programs. This represents a per student cost that ranges from \$21 to \$164, depending on the college or community

The Cherokee Indian who raped and murdered three young Girl Scouts last summer has finally been captured.

Justice Morris Pashman of the New Jersey Supreme Court struck down the state's fornication law because it infringed on individuals' rights, the protection of which, he ruled, outweighed the state's interest in preventing venereal disease, reducing the number of illegitimate children and protecting marital relationships and public morals.

A 27-year-old Memphis white woman was locked in the trunk of her car for eight hours by two blacks who finally abandoned the car in a Negro neighborhood. Next morning a black youth heard a faint cry and let the woman out. Seeing where she was and considering what had happened to her, her first reaction was to run as fast as she could to the nearest white neighborhood.

Carter's Labor Department threatened Hughes Aircraft Co. with the loss of nearly \$911 million in government contracts because company officials allegedly subjected a black male worker in its El Segundo, California, plant to "racially insulting" language and later fired him when he complained.

The two convicts who kidnapped a busload of California school children have joined the ranks of the born-again Christians, who include Charles Watson and Susan Atkins (the butcher of Sharon Tate), Eldridge Cleaver and Charles Colson. Susan Atkins, by the way, has now asked for the right to baptize.

The three-part NBC spectacular on Martin Luther King was the lowest-rated TV show the week it appeared. A Burt Reynolds movie on CBS had more than twice the audience, as did ABC's "How the West Was Won."

The Friends of History, a Canadian group has made a massive mailing of four-color brochures offering for sale a ten-volume set on the Holocaust. Each volume costs \$8.95. So for \$89.50, "plus postage and handling," the interested reader can obtain the antithesis of Arthur Butz's *Hoax of the Twentieth Century*, the paperback edition of which sells for only \$5.00. Incidentally, the main illustration in the brochure features a death camp inmate who is both blond and blue-eyed.

Israel gets 48% of all U.S. foreign military credits and 97% of all outright military grants (*Newsweek*, March 20, 1978, p. 28).

Fallen Atheist

On the media roller coaster first you're up and then you're down. It was all wine and roses for Father Daniel Berrigan when he was burning draft cards during the Vietnam war. But then one day he made a capital gaffe. He had some kind words to say for the Palestinians. The hero was diabolized. He found his second defrocking by the media far more humiliating and financially embarrassing than the one meted out by his bishop. Silence for the loud of mouth is a crueler punishment than death.

The same Luciferian fall has now befallen Madalyn O'Hair, the onetime heroine of the anti-prayer brigade. She was the victorious plaintiff in the 1963 Supreme Court case that banned compulsory prayer in schools. Cushing biographies, extended quotations, mammoth publicity—there was nothing the media wouldn't do for her.

Then all of a sudden she grew horns and a forked tail. Why? What? How? Well, an article appeared in the May 17, 1978, issue of the *New York Times*, which put her on the *Times* and liberal-minority index. She "has allowed the expression of anti-Semitic attitudes." No more need be said. Mrs. O'Hair is finished, kaput, Hitlerized.

As for the details, Mrs. O'Hair on a recent trip to New Jersey in her 1977 Fleetwood Cadillac had the temerity to purge eight members of her American Atheist organization because they had not renounced all aspects of their Jewish heritage and were writing about Judaism from a "goddist" viewpoint. She said it was essential for atheists to "think of ourselves as atheists only, not as Jewish or French or Irish or what have you." She then tried to make amends by talking about a deep dark family secret. It appears her "mother's grandmother was a Jew" and her eldest son married a Jewess "and that Jewish woman was the mother of our much beloved Robin Eileen Murray-O'Hair, my granddaughter."

But she spoiled it all by adding, "We can no longer afford to give a special place to the Chosen People as special atheists" and by defending her younger son, Jon Garth Murray, who had written a New Jersey atheist, "I don't like hypocrites, liars and Jews, all of which you qualify for."

We are afraid that Mrs. O'Hair, having experienced the giddy heights of media apotheosis, is in for rough times. If she hasn't already, she soon

will be crying the blues of Dante's Francesca da Rimini: *Nessun maggior dolore che ricordarsi del tempo felice ne la miseria*. No greater grief than the memory of good times in bad.

The Semitic Scene

The low mental and moral level of America was vividly underlined by the Senate debate over the sale of war planes to Israel, Saudi Arabia and Egypt. No one, least of all the media, seemed to take into account the national interest. All the dramatic tension was concentrated on the "victory or defeat" of the Israel lobby. The protagonist was Jewry, not America. All the empathy was lavished on the hero, in this case the tragic hero, Israel, the "loser" (losing being defined as getting everything one wanted, though not being able to stop others from getting some of what they wanted). The dramatic theme was, to paraphrase JFK, "Ask not what you can do for yourself, but what you can do for your parasite."

The vote of certain senators on the arms sale to the Middle East deserves comment. Israel frontmen like Bayh, Case, Church, Jackson, Kennedy, Moynihan, Proxmire and Talmadge voted as the racial party line dictated, and as one would expect in view of the speaking fees most of them receive from Zionist organizations. The senatorial Jews did likewise, except for Ribicoff and Goldwater (who is either one-quarter or one-half Jewish, depending on who's doing the genealogy). There were a few surprises among Majority ranks. Dale Bumpers, the choice of the Zionists to replace Arkansas's anti-Zionist Fulbright, voted for the sale, as did such previous Israelphiles as Baker, Eagleton, Mathias and Stevenson. On the other hand, such staunch "conservatives" as the late James Allen, Democrat from Alabama, voted nay, as did staunch Republicans like Brooke, Dole, Heinz, Schweiker and Weicker

Five men were recently convicted in London of swindling European banks out of more than \$300 million. The news reports said "allegedly swindling," even though the culprits were found guilty after due process. The stolen money was used to finance such Mafia projects as drug pushing, gambling and prostitution. Henry Oberlander, one of the gang members, had so many false passports in his possession police as yet have been unable to determine his real nationality. The gang itself is called the Hungarian Circle "because most of its members are refugees from German concentration camps." Apparently they were all resistant to Zyklon B. Oberlander asked for

mercy on the grounds that he used the money to track down Nazi war criminals.

The Knesset has now approved a law which forbids the extradition of an Israeli citizen for crimes committed abroad. Hitler, it seems, wasn't always wrong. On page 325 of *Mein Kampf* it is written:

It doesn't even enter their heads to build up a Jewish state in Palestine for the purpose of living there; all they want is a central organization for their international world swindle, endowed with its own sovereign rights and removed from the intervention of other states: a haven for convicted scoundrels and a university for budding crooks.

Meanwhile, the FBI continues to round up a gang called the Israeli Mafia in the Southwest. Members specialize in phony bankruptcies after receiving shipments of valuable goods from big corporations.

Two of the biggest tax cheats in the history of the IRS are Morris Lansburgh and Samuel Cohen, both recently deceased, who failed to report \$15 million in gambling profits, their share of \$20 million in taxes and fraud penalties owed by the now liquidated Flamingo Hotel casino in Las Vegas. An even bigger tax dodger is Allen R. Glick, who owes the IRS \$9.5 million in back taxes and fraud penalties for his real estate operations, his Las Vegas deals and his huge, inexplicable borrowings from the Teamsters' Pension Fund. In connection with these million-dollar tax frauds, it should be noted that they are only for the year 1973 for Lansburgh and Cohen and for the years 1972 and 1973 for Glick. We wonder what the grand total would be if all the tax returns of these gentlemen had been audited.

Interest on the Israeli public debt will amount to 35% of the country's budget in 1979. In 1980 or 1981 the interest is expected to reach 50%. As the London *Spectator* wrote, "It is peace which truly threatens Israel, not war."

The Vatican organ *Osservatore Romano* has criticized the Italian survivors of Nazi persecution, "above all, members of the Jewish community," for refusing to forgive Herbert Kepler, the 70-year-old former SS colonel who escaped from his Italian prison after coming down with terminal cancer. Kepler managed to make it to Soltau, Germany, where he died. Meanwhile, Rudolf Hess, the twentieth century prisoner of Chillon, is still alive and rotting in Spandau.

Max Fisher, the leading Jewish financial backer of the Republican party, recently stepped down as chairman of

United Brands, whose earlier chairman, Elie Black, Fisher's good friend, threw himself out of a window a few years ago when people began to learn about his financial aberrations. Fisher, who owns 728,000 shares or 6.7% of the company's outstanding stock (currently worth about \$4.5 million), was recently charged with benefiting illegally from inside tips on the purchase of land for the development of the Renaissance Center, a hotel-office complex in downtown Detroit.

Deracination Money

Richard Shapiro has one of the longest titles in the Washington bureaucracy. He is Assistant Chief, Racism and Mental Health, Center for Minority Group Mental Health Program, Division of Special Mental Health Program, National Institute of Mental Health. Right now Shapiro has a lot of federal money to give away in the form of research grants to investigate the problem of white racism.

The grants are limited to (1) "identification of the deleterious psychosocial consequences of white racism upon white populations," (2) "to the development of specific interventions designed to reduce racial attitudes and behavior," (3) "to the study of the dynamic aspects of institutional racism present at the operational level in mental health and human service agencies." The grants may also be used for the "establishment of a racism and mental health research and development center to implement the research [and] serve as a clearing house for research related to anti-racism."

Once again, it's apparent that Orwell missed the bus. The Big Brothers of tomorrow will not be Communist Commissars, but the Richard Shapiros, who will be empowered by the state to "intervene" against racism—racism meaning not the rampageous, outrageous minority variety, but the static, silent, sad-sack Majority variety. No doubt the day will come when anyone opposed to minority racism will be adjudged insane by Richard Shapiro, who will then take steps to cure this "insanity," first by drugs, failing that by psychotherapy, failing that by a little arm-twisting, failing that by a little arm-breaking.

Stabilization

Cuban troops, in Andrew Young's language, have now "stabilized" Angola by killing 70,000 men, women and children. The Cuban dead, according to the London *Daily Telegraph*, now total 8,000. In proportion to the population of Cuba (or Cuber as the Harvard-educated John F. Kennedy used to call it), this casualty rate is about four times that of the American armed forces in the Vietnam war.

Even though more Cubans are now dying in Ethiopia and Eritrea, there are no antiwar demonstrations in Havana or anti-Cuban demonstrations in Berkeley. Meanwhile, thanks to the Jimmy-Fidel detente, American tourists are now beginning to down frozen daiquiris (with a dash of Cointreau) in Hemingway's favorite Havana haunts.

No, the lexicographers are not redefining human rights. No, the Castro operation in Africa is not neocolonialism or imperialism. It's just that Cuban atrocities are approved atrocities, and in Andrew Young's book an approved atrocity is one that didn't happen.

By My oh My Lai, how Andy used to go on about the American "terror" in Vietnam.

Birchmania

The John Birch Society believes that the Russians had something to do with last winter's storms and unseasonable cold. Robert Welch himself in the *John Birch Society Bulletin* (March 1978), writing about the second of the two storms that hit Massachusetts in January and February, asks:

Was the storm literally *made to order*? Were its nature, its virulence, its target, and its timing all plotted far in advance? And then achieved with remarkable precision by the Soviets; by *Insiders* high up in our government; or by both factions of the *new world order* hierarchy working secretly together?

If Mr. Welch will forgive us for being as conspiratorially minded as he is, we might say that sometimes it seems that the Birch Society has been founded for one single purpose—to act so asininely that it and conservatives in general will

remain forever tainted in the eyes of intelligent Majority members who are just beginning to see the clay feet of liberalism and who might just be tempted, if their common sense was not outraged by Birchite babblings, to take a flyer in another political direction.

Gay News

A rash of intestinal infections and hepatitis is scourging San Francisco, where the world's most fluttering gays have lost their hearts. The diseases are being transmitted sexually in the intimate channels preferred by homosexuals, as proved by the fact that a great many of the infected are pansies in their 20s and 30s. Amebiasis, an infection of the colon, rose from 17 in 1969 to 130 in 1977. Shigellosis, a form of dysentery, increased from 144 cases in 1969 to 180 in 1977. Some of the victims will become lifelong carriers of these diseases.

Meanwhile, gay San Francisco agencies are doing a thriving business. The first gay TV commercial is in the works. The magazine *Gay Life* is now being sold in some San Francisco supermarkets. A local savings and loan firm reports good results from advertising in gay publications. Even the fairly respectable Chartered Bank of London is going gay with its advertising.

Having no families to support, gays have a lot of extra money to throw around. They realize they have the makings of a powerful consumer pressure group. A gay Yellow Pages? One has already been printed.

Burner Biko

We have heard about the "martyred" black South African Steve Biko. But have we heard any of his speeches? Here is an excerpt from one given shortly before he was thrown in jail.

This is an appeal to all black people to show solidarity with the exiled and the jailed . . . Wherever you are, organize yourselves into groups to deal with those who do not heed this appeal. Beat them, burn their books, burn their cars and shops. Show no mercy to informers and other collaborators—they must all be killed. There must be cries, burning houses, people with clenched fists, bodies lying in the streets, bruised and bleeding people—then there will be freedom—yes, freedom . . . Long live the revolution. Power to the people.

generations, for every ten English-speaking whites now living in New York City, there will be only 1.27. In Los Angeles the white population, which stood at 80.9% in 1947, will be down to 44.4% in 1980, while the black population, 8.9% in 1950, will be 21.5% in 1980 and the Hispanic population, 8% in 1950, will be 27.5% in 1980. The differential fertility rates of the various population groups are responsible for similar trends throughout the U.S. In 1973 the national fertility rate for blacks was 2.4; Catholics 2.2; non-Catholic whites 1.55. Since it is difficult to keep an accurate check of births and deaths in ghettos, the black figure may be much too low. To add to the problem, both legal and illegal immigration is at least 80% to 90% non-white.

The large increase in the number of minority members and of the aged (who will represent 28.1% of the population in 2050) will wreak havoc with the U.S. economy by putting almost unbearable stresses and strains on welfare. For example, General Motors had ten active workers for each retired worker in 1957. In 1977 it had four active workers for each retired worker. Faced with retirement costs such as these, the huge social subsidies of the future can only be scrounged from defense appropriations and space programs. As its military might de-

clines, the U.S. will be forced into a new isolationism. The strategy of "Fortress America" combined with massive nuclear retaliation will necessitate the abandonment of the more expensive "flexible response" policy which is tied to conventional or limited nuclear warfare. Consequently, American military strength in Western Europe and the eastern fringe of Asia will have to be sharply cut back, if not eliminated. Israel, without American cash, will be re-Arabized. Overall, the pattern will probably follow Britain's, whose old age benefits and defense expenditures represented 11.8% and 24.1%, respectively, of the British budget in 1951. Twenty-two years later, in 1973, British old age benefits had climbed to 17.7%, while the defense share of the budget fell to 12.6%. (Incidentally, London, which now has a population of 7,000,000, is expected to be down to 5,200,000 in 1991.)

America in 2078, with only a small Wasp minority and only the remnants of other Majority population groups, may not be a very pleasant place to inhabit. Equally dismal is the prospect of the steady etiolation of other Northern European populations in Europe, Canada and Australia. What it all adds up to is the eventual decimation of the Nordic race.

When the Nordics of ancient Greece were bred out, the Nordic rulers of the

Roman Republic took over. When Rome went down, the Nordic Teutonic tribes filled the vacuum. No repetition of such Nordic transplants seems likely after the Northern European peoples in Europe, North America and Australasia go under. Where would the Nordics come from? An invasion and settlement of Europe by Eastern Slavs, before their own relatively low fertility rates did them in, would be largely an Alpine infusion.

There remains but one cause for optimism. A direct confrontation with the prospect of a Second Death may stimulate Majority leaders to take the desperate steps necessary to prevent it. The first step in an effective Majority population policy would be the establishment of a mandatory Majority fertility rate of 4.2, which would double the Majority population every generation. With each Majority woman having four to five children in her lifetime, the Majority could again become the Majority in fact as well as in name. Hopefully, as the result of an intelligent application of both positive and negative eugenics, plus the use of new genetic technology, it would be a more racially aware Majority, a Majority that would never again be taken in by the specious reasoning and anti-biological myths that not only imperil our race, but the very process of evolution itself.

I am led to believe that the North American continent, not quite yet, but in due time, is to receive only slightly differing versions of the same treatment. Different circumstances obviously require slightly different techniques. For instance, the destruction of European civilizations in Moslem North Africa, that is, the elimination of white men and the definition, as one Algerian wag put it, of white women as "abandoned property," was effected by only slight variants of the current pattern in Black Africa.

Ever since the Eisenhower administration—with only minor and temporary setbacks now and then in Congress—every step of U.S. policy on race matters as pushed by the courts and the executive branch has had no other rational purpose than to prepare for an African-type confrontation. Obviously, this has never been a stated purpose. Nor is it at all likely that many people have thought through the consequences of the educational, industrial, welfare and military aspects to realize that they are

not coincidental, but were deliberately planned as a unit, and as a unit do not have an accidental or coincidental consequence that was foreseen by the political operators who have engineered this revolution in race relations.

Obviously such a proposition cannot be documented, when by documentation we mean, as we must in the present-day United States, the self-serving public statements distributed by the mass media or books published by leftwing publishers, there being almost no others.

The Jewish aspects of modern politics would seem to me to be quite secondary. The Jews with whom we are mostly concerned are those whose ancestors have lived for about a thousand years within the Christian West. This includes the Jews from present-day western Russia, but excludes the very different Jews from southeastern Russia and the quasi-Islamic Jews of North Africa and the Near East. The former are by and large physically indistinguishable from Christians of similar long ancestry in the same areas. They differ in having developed a subculture based on education and money as the basis of social rank. For the

last 150 years as the democratic mania gathered momentum and education began to outrank family as the essential key to individual status, the differences between persons of Jewish and persons of Christian ancestry have gradually diminished, and today are hardly more than trivial. Poor Jews have been as easily used by Soviet propaganda as well-to-do Christians. Also, of course, all Jews have been swept along in the Israeli performance, while most persons of Christian descent care very little about it, one way or the other.

To my mind these facts leave the motivation of the bulk of U.S. foreign policy totally inexplicable if one assumes (a) the motive is rational and (b) there is not a Soviet-manipulated political faction in a very powerful position in American public life, both in the government and in the all-pervading media. Everyone with any sense knows there is a powerful Jewish influence in our total public life. Now if you assume that this is the only centrally directed influence you are left with a maze of actions, foreign and domestic, whose only result has been to assist the operations also being

assisted by the Soviet government, the most immediately obvious of which is the promotion of a world black revolution here and in all the other onetime colonies of the white powers of Europe. In whose interest is such a revolution? Hardly that of the Jews. One would need something a little more realistic than the proposition that a Pretoria-Tel Aviv axis threatens the Soviet Empire with nuclear war.

I know, not by academic certification as an approved scholar in the field, but by having lived in intimate contact with the process itself, that a pro-Soviet political faction became the controlling interest in the Democratic party under Roosevelt and Truman; that the same group obtained effective domination of the Republican party in the capture of its

presidential nomination for Eisenhower. Prior to that time there was a certain amount of public and sometimes governmental agitation about "Communists" (a purely infantile aspect of what was really involved). But ever since there has been total official and unofficial silence on the matter. If there ever had been "Communists" in the government, J. Edgar supposedly got them out. Besides, there probably weren't any anyway. And as for a faction operating in American politics, what on earth is a faction? Historians are well aware of the constancy of such a phenomenon, but our democratic scholars, high and low, never seem to have heard of the word.

For these reasons I feel it is ill-advised to take the public verbal stance of the Jews too seriously. The question seems

to me to be not whether the Jews are changing their sentimental stand toward the Soviet Empire, but whether the Soviet Empire has changed its plans for the rest of the world, including the North American continent.

My honest opinion is that things have probably reached the point of no return and that there is very little anyone can now do to lessen the dreadful consequences of the political follies of democratic liberalism. After all, they have grown in number and enormity for well over a century. I prefer therefore to put as little thought and time as possible on such a useless matter and am devoting myself mostly to what maybe can be done to rescue Western physics from the pitfalls of Levantine thought, i.e., from popular Relativity.

growth consequences are compared with the zero population growth of the white British, that realisation of our future would produce revolution and the end of their parties.

It proves, if anything more is required, that all existing parties have joined without dissent in a cynical club to dupe the electorate into giving them further licence, while continuing to destroy everything worth living for in this country. We actually pay them to betray us! No doubt Moscow or Washington know more about these people's real motivations than their constituents ever will!

events that are unexplained, usually because there is insufficient reliable evidence to provide a clear explanation, occasionally because no one has taken the trouble to investigate them. All that is necessary to excite the gullible is to claim that "Science has no answer," as though "Science," like the Roman Catholic Church had dogmas fixed by a supposedly supreme authority. I do not know how many bundles of silly maundering about the "mystery" of the "Bermuda Triangle" have been vended by knavish publishers and their feckless or cynical hacks—perhaps a dozen in the past few years—but any one of them will serve as a good example of the technique for concocting wonder books, since one has only to read them in conjunction with *The Bermuda Triangle Mystery* by Lawrence David Kusche, who took the trouble to investigate the canard.

Ships, and more recently aircraft, have always "disappeared" at sea, that is to say, have sunk out of the sight of surviving witnesses, and they do so on all the oceans of the world with a frequency that is directly proportional to the number of craft operating in a given area and the navigational hazards. The first step in mystery-making is to give your readers the impression that ships and planes only rarely disappear outside the area you are talking about. Very useful to somewhat cautious writers are the common rhetorical tricks of the trade. If you say, "There are no centaurs in the five southern counties of Pennsylvania," you tell the indisputable truth, but uncritical readers will assume that there are centaurs in the rest of Pennsylvania. You may confidently assert that Carter "told the truth" in his last speech, because, if challenged, you will surely be able to find in the text some statement that is true, such as his reference to the date or the place from which he spoke.

The next step is to rehash all the tales told by your predecessors, being careful to verify none of them. Mr. Kusche, for example, telephoned one man who was amused to learn that he had vanished from the earth, a victim of the terrible Triangle. The *pièce de résistance* served up in all the wonder books is the awfully mysterious disappearance of five naval bombers on a training flight in 1945. Mr. Kusche consulted the report of the official naval inquiry and found that the cause had

been quite satisfactorily ascertained and was not in the least mysterious. A schooner was found derelict and inexplicably abandoned by its crew, which had simply disappeared. Mr. Kusche found the newspaper which contained the nucleus of the story, naturally much embellished as it was used and reused by the hacks, and he noted that the same newspaper had reported two days later that the crew had turned up and doubtless explained what had happened.

When making mysteries about the Triangle, a conscientious man will make certain that he has no atlas at hand, lest he be tempted to use it. Some of the oft-rehashed "mysteries" in the wonder books are provided by ships or planes that are known to have disappeared eight hundred or a thousand miles from the dread Triangle—one even in the Pacific Ocean. A writer must also avoid curiosity about the weather. If he can state that the newspapers in Miami reported that a given day was calm (in Miami), he must not try to ascertain what the weather was in Bermuda, near which some little boat disappeared, because the chances are that he will find there was a violent storm or even a hurricane, and that it would have been really wonderful, had a small cabin cruiser operated by landlubbers survived in such seas. And so it goes. Some of the famous "victims" of the Triangle are ships that seem never to have existed. If they were not invented by the first mystery-peddler to mention them, they probably came from fiction by obscure authors. Mr. Kusche noted, for example, that the familiar and endlessly repeated version of one "mystery" comes from a short story written by Sir Arthur Conan Doyle early in his literary career about a ship which he called the *Marie Celeste*, thus imitating the name of the *Mary Celeste*, a derelict that, years before, had actually been found east of the Azores, and of course, very far from the horrible Triangle. But it's a good story, and it would be a pity not to help impressionable readers stir their imaginations with it.

When a literary beachcomber has collected enough flotsam and jetsam to package as historical data, he has only to make his typewriter register awe and ask, "Did a flying saucer kidnap the crew of the *Marie Celeste*? Did astronauts from an advanced civilization crave a chat with some careless fishermen? Is there, in the unseen depths of the Caribbean, a space terminal that amphibians from Mars keep secret by annihilating humans who are too inquisitive?" And when his readers

are all agog, he must not forget to say something about "psychic forces." Those magic words are to boobs what catnip is to cats.

I have given the basic recipe that will serve, *mutatis mutandis*, for wonder books on any subject. Such books are relatively innocuous. Their authors, if careful to remain ignorant, need not actually lie. Their purchasers doubtless receive two-dollars-worth of titivation. And if the credulous must have their fantasies, it is best that they excite themselves about what are purportedly physical phenomena, which will therefore be subject to empirical verification sooner or later, rather than intoxicate themselves with nonsense about spooks and the "occult learning" hawked about by sloe-eyed swamis, ape-faced maharishis, howling dervishes, and other fast-talking holy men.

There is here a fundamental and crucial distinction. If a sucker for "pyramid power" buys a plastic pyramid to set up in his living room so that he can take baths in "bio-cosmic rays," he will eventually become tired of squatting under the magical frame and come out to spend his money for the next invention of our tireless con men. If he is persuaded by the best-selling Mr. Norman that the earth is hollow, he will not hasten to the North Pole and jump into the big hole which, we are unblushingly told, was discovered by Admiral Byrd. And if he takes comfort in the notion that he is the bastard descendant of god-like astronauts who copulated with female apes in some geologically remote era, the wiseacre is at least thinking in terms of biology, however grossly misunderstood, and is not befuddling himself with far more preposterous myths about the origin of our species. If he must believe wild stories, let them not be about the supernatural.

If a man buys a perpetual-motion machine, he may eventually learn something about mechanics. If he practices witchcraft, he has taken leave of his senses.

That statement is not too drastic. Some of the largest piffle-publishers compete on the newsstands with such publications as *The Witch's Bible*, *The Witch's Handbook*, and *The Witch's Workbook*, to instruct do-it-yourself witches in the art of tying funny knots in strings, putting the hex on their rivals, and selecting for their conjurations the demon who is a specialist in the kind of work they want done. These compilations of esoteric lore must be sold in large quantities to be so profitable, and must be purchased by per-

sons who have been taught (perhaps mistakenly) how to read. Enterprising journalists have compiled almost unbelievable statistics about the number of persons who are now practicing such hocus-pocus, but even if we discount their figures for the galloping inflation normal in journalism, it still seems certain that all over the country thousands of mentally impoverished wights, male and female, regularly assemble in small covens to call up Sabathiel, Asmodeil, Sazquiel, Zazonash, or another one of the thousands of mighty imps that were duly catalogued and classified by the Kabbalists when they were fleecing the Europeans in the Middle Ages. Now, week after week, the witches and warlocks must discover that, no matter how malodorous the grease with which they smear themselves, no matter how many salamanders they catch or buy from their supply houses, no matter how many grotesque capers they cut while the brimstone burns on their altars, they cannot get their message through to the demon of their choice. And even when they utter the secret names of Satan to put the heat on unresponsive devils, the invisible spirits presumably laugh silently. So night after night and year after year, the frustrated magicians must learn from experience that their antics are futile—must learn that the hallucinations produced by their overheated imaginations will have no effect on the world about them. Nevertheless, their teachers tell them, "You must have Faith"—and so they have. So great is their Faith, indeed, that they seem content with the rigmarole packaged for them by New York publishers, and lack even the modicum of mental energy that would send them to more authoritative grimoires, such as the compilations of Solomon, Pope Honorius and comparable masters of the occult science, from which they might learn more potent conjurations that would bring recalcitrant spirits to heel.

The witches and warlocks are a witless lot, but they are not Cajuns lurking in the delta of the Mississippi. The available information indicates that, although few covens are now operating on the campuses of colleges and universities, many of the adepts possess pieces of paper on which unscrupulous educators have certified that they have earned a bachelor's degree or even the degree of *Artium magister*. This incidence of crack-

brained superstition among the supposedly educated is a comparatively recent development. It was about fifteen years ago, as I remember, that youngsters at the University of Oklahoma were arrested for stealing consecrated wafers from Catholic churches, intending to use an aggregation of the magic crackers to resurrect a much admired cinema actor who had died some two years before, but who, it was assumed, would be repaired and put in working order before popping out of his coffin. The news seemed remarkable at the time; it would occasion no astonishment now.

Twenty years ago, newspapers and periodicals that sought to appear respectable carefully ignored the waning business of the astrologers. Today, very few papers are without their staff astrologers, and even some of the leading pornographic journals have found it profitable to keep their readers informed of the days on which the stars will favor intensive forms of endearment. It would seem that the obsession to believe what is preposterous has kept pace with the great increase in astronomical knowledge, and that literate boobs can put their trust in planetary "influences" at the very time that good photographs of the surface of Venus and excellent photographs of the boulder-strewn deserts of Mars are available for all to see.

Astrology, to be sure, was at one time an hypothesis that could be entertained by rational men, and that was true even after it became obvious that the planets were not celestial lanterns created and operated by gods. It has always been a matter of common observation that the children of one man by one woman, in circumstances that exclude a suggestion of adultery, invariably differ from one another, unless they are identical twins, and from their parents, and that the differences in temperament and mentality are far greater than the differences in color of hair and eyes, stature, and other physiological traits. In the days of Manilius and even in the time of Cardanus, the innate differences between offspring of the same parents, born at different times but in the same place and nurtured in the same way, could most easily be explained in four ways, viz.:

(1) Metempsychosis, it being assumed that living bodies are animated by immaterial but imperishable entities called souls, which, when one body dies, pass in some way into another; thus each newborn child was an incarnation of an individual soul that had a character formed by its own peculiar experiences in

many former lives, which it had conveniently forgotten.

(2) Creation, it being assumed that each child was animated by one of the many souls created by a god who, like an artist fashioning figurines, made no two of his products exactly alike, and having accumulated a supply of his creations, either took one at random from a grab-bag when a woman was about to give birth to a child or selected a particular one from the shelves of the warehouse in which he kept his stock ready for use.

(3) Astrology, since time was the significant variable in the phenomena, the moment of conception and/or birth might be the determining factor, and since seasons of the year and phases of the moon were seen not to have such effects, the position of the various planets might correspond to the influences determining character.

(4) Unidentified natural forces that could not be observed.

Of these four hypotheses, the first two naturally commended themselves emotionally to persons who, sharing the instinctive fear of death that is common to all mammals, craved assurance that they were immortal. Men who could subordinate emotional yearnings to the capacity for objective observation that may be peculiar to our race, had to choose between the third and fourth, with a natural prejudice against assumption about unidentifiable causes. The third hypothesis, however, had certain corollaries. Character to some extent obviously determines a man's choices and hence his life. For example, a man born with a pugnacious and adventurous temperament is much more likely than a timorous man to elect a military career, and hence more likely to die on a field of battle. Furthermore, if the various planets exert influences that form character, those influences over the earth must be continuous, and it is only reasonable to suppose that a man formed by a given influence will be affected by that and other influences throughout his life—conceivably even to the extent that his decisions will be made by forces acting upon him. Consequently, his belief that he has freedom of the will is merely an illusion. The corollaries create difficulties, of course. If it could be shown, for example, that all men who die in battle were born under specific planetary configurations, there would be no problem. But even a limited observation suffices to show that the corpses on a battlefield cannot be identified with any set or sets of planetary conjunctions or opposites. Despite these and other difficulties in theory, however, astrology remained

an hypothesis that could not be categorically rejected before the processes of genetics and heredity were scientifically ascertained.

Astrological theory, especially in the version that held that planets exert influences that are strong but not irresistible (*sapiens dominabitur astris*), might have become the universal belief of the Western world from the fourth century B.C. to Victorian times but for the opposition of the theologians of the various cults, who saw that any belief in natural laws would be very bad for businesses that

depended on popular faith in a capricious god or gods who might do anything, if not properly informed and advised by expert holy men. The salvation hucksters, although competing furiously among themselves, all denounced "godless" astrology with the fervor with which the great spiritual shepherds of our own day denounce "Science," which threatens impiously to diminish the flocks they lead to righteousness and the shearing-sheds. In the end, however, the more alert theologians had to compromise and devise the formula, *imperant astra, sed*

astra regit Deus, thus conceding that human life was governed by the planets, but with the proviso that the mighty planets were themselves subordinate to an omnipotent and heavenly king, who had power to neutralize the astral influences and would often do so for his deserving subjects; if they solicited his intervention through the proper channels. Unable to overcome astrology, the nimbler theologians joined it.

moral grounds. This is by no means the whole explanation. When in 1952 Germany was asking to be welcomed back in the Western community, German leaders attended the London Debt Conference, which took up the matter of the various claims and reparations on Germany by all the Allied powers. At that time Israel was demanding \$1.5 billion from West Germany. Konrad Adenauer wrote in his *Memoirs*:

It was clear to me that, if the negotiations with the Jews failed, the negotiations at the London Debt Conference would also run aground, because Jewish banking circles would exert an influence upon the course of the London Debt Conference which should not be underestimated. On the other hand it was self-evident that a failure of the London Debt Conference would bring about a failure of the negotiations with the Jews. If the German economy was to achieve a good credit standing and become strong again, the London Conference would have to be ended successfully. Only then would an economy develop in a way that would make the payments to Israel and the Jewish organizations possible.

To drive the nail home, Nahum Goldman, then head of World Zionism, warned Adenauer that if West Germany didn't pay up:

The violent reaction of the whole world, supported by wide circles of non-Jews who have deep sympathy with the martyrdom of the Jewish people during the Nazi period, would be irresistible and completely justified.

The *London Jewish Chronicle* growled:

The whole international weight of World Jewry will be mobilized for an economic

war against Germany, if Bonn's offers of reparations remain unsatisfactory

The Germans, of course, caved in. The Zionists' claims at the London Debt Conference were settled before those of the Allies. As a matter of fact, Great Britain and the U.S. reduced their claims on Germany so the West Germans would have an easier time paying off the Zionists. This reduction could be considered as one more Israeli bite on the American taxpayer.

It is interesting to note that, when considering the 1953 treaty with Israel, Bundestag members voted 238 for, 30 against, with 86 abstentions. The only opposition came from the far right and the Communist party, which by then had been declared illegal. At the same time a nationwide poll showed that only 67% of the West German population had heard of the reparations negotiations. As for the 3 billion mark payment specified in the treaty, only 11% of the West Germans said they agreed, with 21% undecided.

It has always been the opinion of *Instauration* that West Germany's total submission to Jewish financial demands was a calculated policy of the West German leadership. Realizing the immense power of Jewry and faced with the imposition of the Morgenthau Plan, which was intended to destroy Germany forever, the post-World War II German political leaders, led by Adenauer, secretly agreed to give Jews whatever they wanted in the hope that this would permit West Germany to survive. Sooner or later, because of growing Arab pressure and the weakening power of the U.S., West Germany's subservience to Jewry will have to slow down. Meanwhile, the Jews remain in

the driver's seat. If West Germany should refuse any of these demands, all the Jews have to do is fire up the media with stories of neo-Nazism, hire a few agents to burn down a few synagogues and desecrate a few graveyards, and the West German government, as it has responded to similar psychological warfare in the past, will meekly carry out whatever orders it receives from New York, Washington and Jerusalem.

Howard Allen recently received a request for a free copy of *The Dispossessed Majority* from Allen Smith of the Board of Studies in Psychology, University of California at Santa Cruz. He said he was teaching a course called "The Social Psychology of the Silent Majority" and added that the book "may be adopted as a required text in my course." We respectfully request Instaurionists in Santa Cruz who have a little time on their hands to drop by Mr. Smith's office and see whether he has actually made *The Dispossessed Majority* required reading. We must warn our friends, however, not to be too sanguine about the matter.

San Francisco: Nazis have mounted a \$28 million damage suit against local Jews as a result of last April's fiery destruction of the Rudolf Hess Bookstore. Geoffrey Fisher, managing editor of the San Francisco *Jewish Bulletin*, was charged with defamation. Damages were also sought from James Ruderman, director of the northern California regional offices of the ADL; Joel Brooks, director of the regional American Jewish Congress; San Francisco Mayor George Moscone; Diane Feinstein, a San Francisco supervisor; and Joseph Freitas, U.S. Attorney. The latter three were accused of negligence in failing to protect the bookstore and in failing to prosecute the hoodlums who had wrecked it and burned it down. Martin and Allan Weiss, who were caught *in flagrante delicto* were found guilty of a misdemeanor and released. The Nazis want \$2 million for general damages; \$1.5 million for punitive damages; \$15 million for threats on the life of plaintiff Allen L. Vincent, head of the Nazi group.

The balance of the \$28 million is allocated to miscellaneous damages.

Palmetto, Florida: The Manatee County Citizens Council scheduled a meeting in the Community Room of the Westgate Branch of the Palmetto Federal Savings and Loan Association. The Community Room has long been a meeting place for all kinds of organizations, including some with a broad and noticeable minority streak. When the news leaked out that Dr. Frank C. J. McCurk, the noted psychologist who believes that heredity has a lot to do with human behavior, was to be the featured speaker, the pressure started to mount. As expected, the Federal Savings and Loan people caved in and told the Citizens Council to meet elsewhere. The Council did. Next day, many of the members withdrew their savings accounts and moved them elsewhere. We suggest that members of the Council go further and sue the Federal Savings and Loan for violating their civil rights, though it must be admitted that Majority rights and minority rights have now become two entirely different legal concepts.

Omaha, Nebraska: Howard Allen occasionally rents some conservative mailing lists for the dissemination of brochures of *The Dispossessed Majority*. The quality of such lists is not very high, as attested by the following letter which reached us through a direct-mail complaint service.

In November of last year, I received an unsolicited brochure from that organization [Howard Allen], advertising a book titled, "The Dispossessed Majority." From the brochure, I gather that the majority the title refers to is white, Anglo-Saxon, and protestant in religious leanings. I also gather that both author and publisher think anyone outside that group needs to be driven out of the country or destroyed.

Garbage like that is about as welcome around our house as porn literature would be. Please advise the publisher that anything more like it will also be reported to the authorities. Further, I'd love to know where they got my name and address, so I could also protest to that source.

New York: On the Bill Boggs Middy Show, Channel 5, there came on April 21 three survivors of the Holocaust, an expert Holocauster named Feingold, and a slew of minority newshounds from the *New York Times* and similar papers. Incredibly, in the midst of this totally hostile environment, like a brave lamb invading a pack of wolves, appeared the honest face of Fritz Berg, an authentic German American, who proceeded to affirm his wholehearted acceptance of Arthur Butz's version of the Holocaust. As Berg pointed out the woeful lack of hard documentary evidence concerning history's most publicized "atrocities," Feingold began to scream, while a Middle East "expert" named Charney stood up,

made a rambling hysterical speech and stormed off the camera. Magda Rosenberg one of the two female "survivors," then wailed that twenty members of her family had been thrown alive into the ovens. At this hectic point the moderator of the show told Fritz Berg to get lost.

Albany: A judge recently ordered mental tests for a high-ranking state employee charged with passing out anti-Semitic literature. The culprit was a senior architect in the Offices of General Services, who was caught placing leaflets critical of Jews on a car windshield. Police said he had a hundred more leaflets in his pocket.

Eugene, Oregon: Dean Kennedy, an ardent 39-year-old Instaurionist, writes:

I am running a low key no budget campaign for a seat in the Oregon legislature. As you may know, Eugene, the site of the University of Oregon, is just about the most liberal place in the Western world. I feel if I get 35-40% of the vote in the Oregon State primary it will be a moral victory because my opponent is a good-looking Nordic type who is spending thousands (to my \$5), but does not have a thought in his head as to what is really going on.

Tennessee: An interesting number has come to light as the result of a referendum held in Tennessee last March. Voting on the removal of the state ban on interracial marriage, which is still on the books but no longer enforced, 197,835 were pro, 186,849 con. This means that despite years of the most intense mind-altering propaganda blitz, 48% of those who voted on the question still wanted interracial marriage to remain an illegal act.

London: Our British Correspondent reports: In the *London Times* of May 4 Michael Ratcliffe, anent the Goebbels diaries, says: "It is not safe to leave innocent and ignorant readers alone with the Reich Minister for Propaganda." Extraordinary! After thirty odd years of unremitting hostile propaganda, it is still not safe to let people read Goebbels without a corrective commentary. Later, Ratcliffe says: "The fact that Goebbel's view of the Allies after the Yalta conference is politically accurate and that his prognosis of Britain's world future after the war has turned out largely correct is sufficient to keep one reading respectfully to the end."
